# INFORMATION FOR VOTERS

## NOTICE TO VOTERS – CALIFORNIA ELECTIONS CODE, SECTION 13312

Pursuant to CA Elections Code, Section 13312, this notice is to inform voters that the county voter information guide does not contain a complete list of candidates and that a complete list of candidates appears on the sample ballot.

Each candidate's statement in the county voter information guide is volunteered by the candidate and is printed at his or her expense.

**CHECK YOUR REGISTRATION:** If you have interacted with the DMV, your voter registration information may have been inadvertently changed. It is important to confirm your voter status, political party affiliation, and other information to make sure you are still registered correctly. Check your status at [voterstatus.sos.ca.gov](http://voterstatus.sos.ca.gov).

★ **DAMAGED BALLOTS:** If you incorrectly mark, tear or spoil any portion of your ballot, a replacement ballot can be issued. Please contact the Placer County Elections Office for instructions – you can find our contact information on the front cover of this guide.

★ **LOST THE BALLOT MAILED TO YOU:** If you lose, misplace or discard your ballot that was mailed to you, you may request a replacement ballot be sent to you or vote a ballot in person at the Elections Office in Auburn beginning October 10. Contact the Elections Office for directions – you can find our contact information on the front cover of this guide.

★ **VOTING BY MAIL:** Postage is not necessary when returning your ballot. After you have completed voting, review your choices one final time to be sure they are correct and place your ballot in the return envelope provided. Be sure to **sign and date** the envelope where required. The envelope must have your signature on it, or the ballot cannot be counted. Return the envelope according to the instructions you receive with your ballot. If you wish to return your voted ballot by mail, it must be postmarked by Election Day, November 8, and received by the Elections Office no later than Tuesday, November 15 for your ballot to count. We encourage you to mail your ballot early so it will arrive on time. If you wish to return your voted ballot in person, it must be hand-delivered at or before 8 PM on Election Day. For your convenience, we have various types of ballot drop-off locations in the county, including 24-hour boxes. For additional information on drop box hours and locations in Placer County, see page “DROP.”

★ **VOTING AT YOUR POLLING PLACE:** If you would prefer to vote at your polling place instead of by mail, bring your ballot and envelope with you to avoid the potential of voting a provisional ballot. After you have completed voting your poll ballot, look over your choices one final time to be sure they are correct, place your ballot in the secrecy sleeve, and deposit the ballot into the ballot scanner. **Please note – your polling place may have changed. Check the back cover of this guide for your polling place.**

★ **OPTIONS FOR RECEIVING YOUR VOTER INFORMATION GUIDE:** State law (AB 1717, established in 2010) allows voters to opt out of receiving their voter information guide by mail and accessing it electronically, instead. # NOTICE TO ALL PLACER COUNTY VOTERS

**As required by state law, all active registered voters will receive a ballot by mail.**



- The official ballots will be mailed out to all voters no later than October 10.
- All active registered voters within the county will be mailed a ballot for this election. We encourage voters to vote and return their ballot as soon as possible.
- Ballots can be returned by mail in the prepaid postage return envelope, or;
- Dropped in an official ballot drop box placed throughout the county starting October 11 (see page "DROP" for locations), or;
- Returned in person to any polling place on Election Day.

## **Why do my districts look different on my ballot?**



Following the 2020 Census, districts were redrawn to rebalance populations. What this means to voters is that the districts you are used to seeing on your ballot may have changed. Additionally, polling place numbers and locations may have also changed. The redistricting process considers shifts in population since the last census, making sure constituents are represented equally in accordance with the "one-person, one-vote" principle of the Voting Rights Act.

## **What if my ballot is misplaced, spoiled or not received?**

- Call the Elections Office for instructions on how to request a replacement ballot at 530-886-5650 or email us at [vote@placer.ca.gov](mailto:vote@placer.ca.gov). This must be requested by November 1, 2022 (7 days before the election).
- Visit the Placer County Elections Office (2956 Richardson Drive, Auburn, CA) to cast a vote-by-mail ballot beginning October 10 through Election Day during the following dates and times:
  - Normal Business Hours, Monday through Friday: 8 AM – 5 PM
  - Monday, October 10: 10 AM – 3 PM
  - Saturday/Sunday, October 29 & 30 and November 5 & 6: 10 AM – 3 PM
  - **Election Day** - Tuesday, November 8: 7 AM – 8 PM
- Visit your Placer County polling place on Election Day. Please review the back page of this voter information guide for your assigned polling place. If you choose to go into the Elections Office or a polling place, please be prepared for the possibility of extended wait times.

## **Notice to voters – US Senate (full term/partial term)**

The ballot includes elections for the succeeding term and for the remainder of the unexpired term of the vacated Senate seat.

There are two U.S. Senate contests on the November 8, 2022, General Election ballot.

The first contest is the regular election for the full 6-year term which begins on January 3, 2023 and ends January 3, 2029.

The second contest is a special vacancy election. The current officeholder is temporarily filling a vacancy for the remainder of the current term ending January 3, 2023 (partial/unexpired term).

You may vote for both contests.

# TOP TWO CANDIDATES OPEN PRIMARY ACT VOTER-NOMINATED OFFICES

## Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still must be held.

California's open primary system does not apply to candidates running for U.S. President, county central committee, or local offices.

Write-in candidates for voter-nominated offices can still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

## Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have their qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county Voter Information Guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election, unless the candidate is one of the two highest vote-getters at the primary election.

## Statewide Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

## Countywide Nonpartisan Offices

For countywide nonpartisan offices at the primary election, if a candidate receives a majority of the vote (more than 50 percent of the ballots cast), then that candidate will be elected to the position and that race will not continue onto the general election ballot in November.

- Drop box locations are available starting October 11 through Election Day, November 8.
- **Voted ballots can only be received at drop box locations inside the businesses listed below during their business hours and cannot be received after 8 PM on November 8 regardless of the business hours.** There are multiple 24/7 drop box locations throughout the county for your convenience.
- If dropping off at a library location, please do not put your voted ballot into a library book drop-off slot!

**INSTRUCTIONS TO VOTERS:** To vote for a candidate whose name appears on the ballot, mark the voting target next to the candidate's name. To vote for a qualified write-in candidate, write the person's name in the blank space provided for that purpose after the names of the other candidates for the same office. In addition, completely darken in the oval to the left of the candidate's name on the write-in line. To vote for a candidate for Chief Justice of California; Associate Justice of the Supreme Court; or Associate Justice, Court of Appeal, mark the voting target next to the word "Yes." To vote against the candidate, mark the voting target next to the word "No." To vote on any measure, mark the voting target next to the word "Yes" or next to the word "No." Use a blue or black pen only to darken the oval. Marking the ballot outside of the designated space to vote for a candidate or measure may compromise the secrecy of the ballot. If you wrongly mark, tear, or deface this ballot, return it and obtain another.

### COUNTY COUNSEL'S IMPARTIAL ANALYSIS OF MEASURE G

This measure, if approved by fifty-five percent of the voters, would authorize the sale of general obligation bonds by the Western Placer Unified School District (the "District") in the aggregate principal amount of \$185,000,000. The proceeds of the bonds would be used to provide financing for the school facilities projects described in the text of the measure and more fully listed in the Bond Project List. Principal and interest on the bonds would be paid from a tax placed on the taxable property within the District. The District's estimate of the highest tax rate that would be required to fund this bond issuance is \$54 per \$100,000 of assessed valuation until fiscal year 2056-2057.

A general obligation bond is a form of borrowing commonly used to fund school facilities. By law, local general obligation bonds, financed through an increase in local property taxes, can be used for renovating, reconstructing, and building new facilities and for acquiring certain new equipment. To authorize such bond issuance through a 55% voter approval, the District must meet certain accountability requirements. To meet these requirements, the Board of Trustees of the District has committed to the following:

- to use the bond proceeds only for the purposes set forth in the ballot measure, and not for any other purpose, such as teacher and administrator salaries and other school operating expenses.
- the safety, class size reduction and information technology needs of the District as well as the importance of the projects to student achievement and enhanced instruction have been evaluated prior to determining that bond issuance was necessary.
- to create a Citizen's Oversight Committee in compliance with Education Code Section 15278

no later than 60 days after the Board enters the election results in its minutes to ensure bond proceeds are expended only for the projects in the ballot measure.

- to conduct annual independent performance and financial audits to ensure that the bond proceeds are expended only for the projects in the ballot measure.

This measure was placed on the ballot by the Board of Trustees for the District through adoption of Resolution No. 21/22.27 on June 21, 2022.

A "YES" vote on this Measure would authorize the Western Placer Unified School District to borrow money through the sale of bonds in an amount not exceeding \$185,000,000, with the bonds being repaid by revenue derived from an annual tax levied upon the taxable property within the District.

A "NO" vote on this Measure is a vote against authorizing the sale of bonds by the District.

This analysis is submitted by the Office of the County Counsel of Placer County pursuant to the requirements of Section 9500 of the Elections Code of the State of California.

## FULL TEXT OF MEASURE SUBMITTED BY THE DISTRICT

### Section 1. Specifications of Election Order.

Pursuant to sections 5304, 5322, 15100 *et seq.*, and section 15266 of the California Education Code, an election shall be held within the boundaries of the District on November 8, 2022, for the purpose of submitting to the registered voters of the District the following proposition:

#### BOND AUTHORIZATION

By approval of this proposition by at least 55% of the registered voters voting on the proposition, the District shall be authorized to issue and sell bonds of up to \$185,000,000 in aggregate principal amount to provide financing for the specific school facilities projects listed in the Bond Project List attached hereto as Exhibit A, subject to all of the accountability safeguards specified below. Bonds will be issued in one or more series.

#### ACCOUNTABILITY SAFEGUARDS

The provisions in this section are specifically included in this proposition in order that the voters and taxpayers of the District may be assured that their money will be spent to address the specific facilities needs of the District, in compliance with the requirements of Article XIII A, section 1(b)(3) of the State Constitution, and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at section 15264 *et seq.* of the California Education Code).

*Evaluation of Needs.* The Board has updated its Facilities Master Plan in order to evaluate and address all of the facilities needs of the District, and to determine which projects to finance from a local bond at this time. The Board hereby certifies that it has evaluated safety, class size reduction and information technology and other needs in developing the Bond Project List contained in Exhibit A.

*Independent Citizens' Oversight Committee.* The Board shall establish an independent Citizens' Oversight Committee (section 15278 *et seq.* of the California Education Code), to ensure bond proceeds are expended only for the school facilities projects listed in Exhibit A. The committee shall be established within 60 days of the date when the results of the election appear in the minutes of the Board.

*Annual Performance Audits.* The Board shall cause an annual, independent performance audit to be conducted to ensure that the bond proceeds have been expended only on the school facilities projects listed in Exhibit A.

*Annual Financial Audits.* The Board shall cause an annual, independent financial audit of the bond proceeds to be conducted until all of those proceeds have been spent for the school facilities projects listed in Exhibit A.

#### BOND PROJECT LIST

The Bond Project List attached to this resolution as Exhibit A shall be considered a part of the ballot

proposition, and shall be reproduced in any official document required to contain the full statement of the bond proposition.

The Bond Project List, which is an integral part of this proposition, lists the specific projects the District proposes to finance with proceeds of the Bonds. Listed repairs, rehabilitation projects and upgrades will be completed as needed. Each project is assumed to include its share of costs of the election and bond issuance, architectural, engineering, and similar planning costs, construction management, and a customary contingency for unforeseen design and construction costs. The final cost of each project will be determined as plans are finalized, construction bids are awarded, and projects are completed. In addition, certain construction funds expected from non-bond sources, including State grant funds for eligible projects, have not yet been secured. Therefore, the Board cannot guarantee that the bonds will provide sufficient funds to allow completion of all listed projects.

#### FURTHER SPECIFICATIONS

*No Administrator Salaries.* Proceeds from the sale of bonds authorized by this proposition shall be used only for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses.

*Single Purpose.* All of the purposes enumerated in this proposition shall be united and voted upon as one single proposition, pursuant to section 15100 of the California Education Code, and all the purposes shall constitute the specific single purpose of the bonds, and proceeds of the bonds shall be spent only for such purpose, pursuant to section 53410 of the California Government Code.

*Other Terms of the Bonds.* When sold, the bonds shall bear interest at an annual rate not exceeding the statutory maximum, and that interest will be made payable at the time or times permitted by law. The bonds may be issued and sold in several series, and no bond shall be made to mature more than 25 years (if issued pursuant to the provisions of the California Education Code) or 40 years (if issued pursuant to the provisions of the California Government Code) from the date borne by that bond.

### **EXHIBIT A** **KEY FINDINGS**

- The Western Placer Unified School District ("District") currently serves a population of 7,200 students on 15 school campuses. The District is focused on providing a top-quality education to prepare students for college and 21st-century careers. Rigorous academic programs emphasize reading, science, engineering,

technology, language arts, and math. The District is the local provider of Transitional Kindergarten through 12<sup>th</sup> Grade (TK-12) public education.

- The Board of Education of the District is committed to the belief that all students deserve to learn in quality classrooms and school facilities.
- The District has two key priorities: first, to ensure academic success for every student attending one of our schools; and second, to make sure that our school facilities and school grounds are safe, secure, modern, and equipped to provide the best educational environment possible.
- Student enrollment in the District is increasing and more young families with school age children are moving into the District each year. As a result, many schools in the District are operating at near maximum capacity, utilizing all available classrooms and shared spaces, resulting in cafeterias, gyms and playgrounds being overcrowded.
- The District's long range Facilities Master Plan is continually updated to identify and confirm the needs at every school site and campus within the District has facility improvement needs that require attention.
- The updated Facilities Master Plan was completed with input from school staff, district parents, City of Lincoln representatives and members of the community to identify the upgrades needed at each school site in order to meet modern safety standards, to meet the District's goals for supporting current academic standards, and to address specific priorities at individual school sites.
- The improvements identified in the Facilities Master Plan have been prioritized so that the most critical facility needs are addressed.
- These projects include addressing urgent needs, like replacing aging roofs, plumbing, and electrical systems, keeping schools clean, well-maintained and in good condition, performing essential safety repairs and maintenance on classrooms and facilities, and classroom upgrades for improved teaching and learning in science, math, technology, engineering, and arts.
- Updating classrooms and aging facilities will make schools more efficient and will help cut utility costs, freeing up money to support teaching and classroom instruction.
- Locally-controlled funding from bond measures is the primary means by which all local school districts are able to keep its school buildings and classrooms in good repair, with safe environments, designed and equipped to support changing educational standards, methods and approaches.
- Measure A in 2014 and Measure N in 2016 were the first steps in a comprehensive effort to upgrade aging and overcrowded Western Placer elementary, middle, and high school facilities.
- These bond measures focused on four key projects that were completed successfully and under budget, but the District still has significant facility needs.
- The District cannot rely on the State of California to fund school facility improvements and the limited

state dollars available for facility upgrades typically require local matching funds that could be provided by a local bond measure.

- The District is proposing this bond measure to fund improvements to classrooms, science, technology, engineering, arts, and math labs and other educational facilities to support quality academic instruction for students.
- This bond measure will benefit local schools only and no funds can be taken away by the State or other school districts, and by law, no money can be used for administrator salaries or pensions.
- This bond measure requires strict fiscal accountability protections including mandatory annual audits and an independent citizens' oversight committee comprised of local residents to ensure funds are managed and spent properly.
- This measure will help ensure that Western Placer Unified School District can retain and attract quality teachers and maintain our high academic achievement. By upgrading classrooms and learning technology, the best teachers will want to teach at our local public schools because classrooms will be up-to-date and have greater access to new technology to support 21st century instruction needs.

The Board concluded that protecting the quality of our campuses, the quality of life in our community, and the value of our homes is a wise investment. Therefore, in approving this Project List, the Board of Education determines that the District must:

- Retain all funds to support local students and ensure that money cannot be taken away by the State; and
- Repair or replace deteriorating roofs, plumbing and electrical systems; and
- Upgrade classrooms, science labs, computer systems to keep pace with technology; and
- Upgrade facilities to support student achievement in core subjects like math, science, engineering, arts, and technology; and
- Prevent overcrowding and support the growing student population; and
- Qualify for State matching funds; and
- Adhere to specific fiscal accountability safeguards such as:
  - All expenditures must be subject to annual independent financial audits.
  - No funds can be used for administrators' salaries and pensions.
  - An independent citizens' oversight committee must be appointed to ensure that all funds are spent only as authorized.

#### **ACCOUNTABILITY MEASURES**

**This bond measure has strict accountability requirements including:**

1. All money will benefit local schools and CANNOT BE TAKEN BY THE STATE.

2. Require CITIZENS' OVERSIGHT and yearly reports to the community to keep the District accountable for how the funds are spent.
3. NO ADMINISTRATOR SALARIES. Proceeds from the sale of the bonds authorized by this proposition shall be used only for the acquisition, construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, and not for any other purpose, including teacher or administrator salaries, pensions and other operating expenses.
4. FISCAL ACCOUNTABILITY. THE EXPENDITURE OF BOND MONEY ON THESE PROJECTS IS SUBJECT TO STRINGENT FINANCIAL ACCOUNTABILITY REQUIREMENTS. BY LAW, PERFORMANCE AND FINANCIAL AUDITS WILL BE PERFORMED ANNUALLY, AND ALL BOND EXPENDITURES WILL BE MONITORED BY AN INDEPENDENT CITIZENS' OVERSIGHT COMMITTEE TO ENSURE THAT FUNDS ARE SPENT AS PROMISED AND SPECIFIED. THE CITIZENS' OVERSIGHT COMMITTEE MUST INCLUDE, AMONG OTHERS, REPRESENTATION OF A BONA FIDE TAXPAYERS ASSOCIATION, A BUSINESS ORGANIZATION AND A SENIOR CITIZENS ORGANIZATION. For any project involving modernization or renovation of a building or the major portion of a building, the District shall be authorized to proceed with new replacement construction if the Board of Education determines that replacement and new construction is economically more practical considering the building's age, condition, and other relevant factors.



The listed projects will be completed as needed. Each project is assumed to include its share of furniture, equipment, architectural, engineering, and similar planning costs, program management, staff training expenses and a customary contingency, and escalation for unforeseen design and construction costs. In addition to the listed projects stated above, the Project List also includes the acquisition of a variety of instructional, maintenance and operational equipment, including the reduction or retirement of outstanding lease obligations and interim funding incurred to advance fund projects from the Project List, payment of the costs of preparation of all facility planning, facility studies, assessment reviews, facility master plan preparation and updates, environmental studies (including environmental investigation, remediation and monitoring), design and construction documentation, and temporary housing of dislocated District activities caused by bond projects. The upgrading of technology infrastructure includes, but is not limited to, fiber optic cable and hardware necessary to increase bandwidth.

The allocation of bond proceeds may be affected by the District's receipt of State matching funds and the final costs of each project. In the absence of State matching funds, which the District will aggressively pursue to

reduce the District's share of the costs of the projects, the District may not be able to complete some of the projects listed above. The budget for each project is an estimate and may be affected by factors beyond the District's control. The final cost of each project will be determined as plans are finalized, construction bids are awarded and projects are completed. Based on the final costs of each project, certain portions of the projects described above may be delayed or may not be completed. Demolition of existing facilities and reconstruction of facilities scheduled for repair and upgrade may occur, if the Board determines that such an approach would be more cost-effective in creating enhanced and operationally efficient campuses. Necessary site preparation/restoration and landscaping, may occur in connection with new construction, renovation or remodeling, or installation or removal of relocatable classrooms, including ingress and egress, removing, replacing, or installing irrigation, utility lines, trees and landscaping, redirecting fire access, and acquiring any necessary easements, licenses, or rights of way to the property.

Bond proceeds shall be expended only for the specific purposes identified herein. Proceeds of the bonds may be used to pay or reimburse the District for the cost of District staff when performing work on or necessary and incidental to the bond projects, but not for other administrator or teacher salaries. The District shall create an account into which proceeds of the bonds shall be deposited and comply with the reporting requirements of Government Code § 53410.

## TAX RATE STATEMENT PREPARED BY THE DISTRICT

An election will be held in the Western Placer Unified School District (the "District") on November 8, 2022, to authorize the sale of up to \$185,000,000 in bonds of the District for the specific school facilities projects listed in the Bond Project List established by the District, as described in the proposition. If the bonds are authorized and a State bonding capacity waiver is received, the District expects to sell the bonds in two or more series. Principal and interest on the bonds will be payable from the proceeds of tax levies made upon the taxable property in the District. The following information is provided in compliance with Sections 9400-9404 of the Elections Code of the State of California.

1. The best estimate from official sources of the average annual tax rate that would be required to be levied to fund that bond issue over the entire duration of the bond debt service, based on assessed valuations available at the time of the election or a projection based on experience within the same jurisdiction or other demonstrable factors is 5.4 cents per \$100 of assessed valuation (\$54 per \$100,000 of assessed valuation) of all property to be taxed. The best estimate of the final fiscal year in which the tax is anticipated to be collected is 2056-57.

2. The best estimate from official sources of the highest tax rate that would be required to be levied to fund that bond issue, and an estimate of the year in which that rate will apply, based on assessed valuations available at the time of the election or a projection based on experience within the same jurisdiction or other demonstrable factors is 5.4 cents per \$100 of assessed valuation (\$54 per \$100,000 of assessed valuation) of all property to be taxed. The best estimate of the year in which the highest tax rate will apply is anticipated to be 2027-28.

3. The best estimate from official sources of the total debt service, including the principal and interest, that would be required to be repaid if all the bonds are issued and sold is \$320,000,000.

Voters should note that such estimated tax rates are specific to the repayment of bonds issued under this authorization and are and will be in addition to tax rates levied in connection with other bond authorizations approved or to be approved by local voters for the District or for any other overlapping public agency.

District voters have approved a prior authorization (\$60,000,000 2014 Measure A) under which the District has issued bonds that are still outstanding. In 2021-22, the general obligation bond tax rate is \$28.18 per \$100,000 of assessed value for such authorization. The District has issued all bonds under such authorization. District voters have also approved a prior authorization (\$60,000,000 2016 Measure N) under which the District has issued bonds that are still outstanding. In 2021-22, the general obligation bond tax rate is \$21.08 per \$100,000 of assessed value for such authorization.

The District has issued all bonds under such authorization.

Voters should note that estimated tax rate is based on the ASSESSED VALUE of taxable property on Placer County's official tax rolls, not on the property's market value. Property owners should consult their own property tax bills to determine their property's assessed value and any applicable tax exemptions.

Attention of all voters is directed to the fact that the foregoing information is based upon the District's projections and estimates only, which are not binding upon the District. The actual tax rates and the years in which they will apply may vary from those presently estimated, due to variations from these estimates in the timing of bond sales, the amount of bonds sold at market interest rates at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on the need for construction funds and other factors. The actual interest rates at which the bonds will be sold will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the Placer County Assessor in the annual assessment and the equalization process.

On the next page is a list of precincts that will have translated sample ballots in Spanish, Tagalog, Korean or Punjabi, that voters can use as a reference tool when voting. The precincts that will have them are determined by the Secretary of State. # ACCESSIBILITY/REMOTE ACCESSIBLE VOTE BY MAIL

Placer County has taken measures to ensure that our voters with specific accessibility needs can participate in the elections process.



**Accessible online voter information guide and ballot:** The online version of this voter information guide and the voter's precinct-specific accessible vote-by-mail ballot are both compatible with screen readers. Information on how to access them can be found at [www.placercountyelections.gov](http://www.placercountyelections.gov).



**Accessible voting equipment:** The touchscreen machines at all polling places and the Elections Office allow voters with specific disabilities to cast their ballots in an independent and private manner. The voting equipment is compatible with audio tactile interface (ATI), sip 'n' puff, and paddles. Ballots can be presented in audio only, visual only, or both audio/visual.



**Accessible voting locations:** Every polling place in Placer County has been surveyed by the Elections Office and we have attempted to mitigate all barriers to make them accessible to all voters.

## Remote Accessible Vote-by-Mail (RAVBM)

The Remote Accessible Vote-by-Mail system, or RAVBM, was implemented by California to make voting more convenient for voters with disabilities. Assembly Bill 37 permits any voter to cast a ballot using the RAVBM system for any election. To ensure voters' privacy, the system does not store or transmit votes over the internet. Instead, the ballot is printed and returned by mail or by hand.

**Who is eligible to use the RAVBM system?** Any registered Placer County voter is eligible to use the Remote Accessible Vote-by-Mail system. The voter must have internet access and a printer to mark, print and return their ballot for counting.

**Is the RAVBM system secure?** Yes. The Remote Accessible Vote-by-Mail system has been certified by the California Secretary of State. The RAVBM system does not store or transmit the voter's selections over the internet. Although the RAVBM system allows voters to access and mark their ballots using any computer and their own assistive devices, the system does not allow electronic voting.

**How do I access my ballot through the RAVBM system?** Registered voters can apply for a remote accessible ballot by phone, email, on our website, or on the Secretary of State's website. Once the application is processed in our office, a link to access your voting materials electronically will be sent to the email supplied during the request.

**How do I return my ballot?** After you are finished marking your ballot, it will need to be printed and returned, either by mail or in person, for signature checking and tabulation.

**When will the RAVBM system be available?** Ballots will be available through this system beginning October 10 and until 8 PM on Election Day, November 8. Remember, if returned by mail, it must be postmarked on or before November 8, and received by the Elections Office no later than November 15, 2022 for your ballot to be considered on time and counted.

Working alongside their precinct board, and supported by the Elections Office staff, poll workers play an essential role in making sure that Placer County's elections are secure and conducted in strict accordance with state and federal voting laws. Volunteers learn about the election process and serve their community by protecting voter rights, securing our systems, serving voters with respect, and assisting all voters with casting their vote.

A precinct board consists of an Inspector, Judge, and Clerks. Poll workers are eligible to receive a stipend that can range from \$100-\$160, depending on the position. Paid training is also provided. Volunteering can also be a great fundraising opportunity for your service club, school booster club or church group. Groups can earn up to \$900 by attending training classes and staffing an entire precinct board on Election Day!

Volunteers must be able to work from **6:00 AM to 9:00 PM on Election Day, Tuesday, November 8**. Apply by filling out the form on the next page and mailing, emailing, or faxing it back to us. 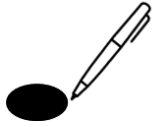

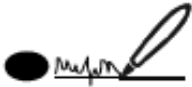
# HOW TO FILL OUT YOUR BALLOT

*You may use the sample ballot in this guide as reference when filling out your official ballot.*



On your official ballot, completely darken the oval next to your selection with **blue or black ink**.

If you are voting for a qualified write-in candidate, you must completely fill in the oval AND write the name of the candidate in the space provided. **Unless both steps are completed, your vote for a write-in candidate cannot be counted.**

**DO NOT make partial marks** when you make your selections. X marks, check marks, and other kinds of partial shading on the ovals are not the right ways to fill out your ballot.

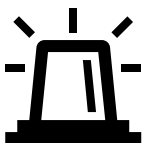
Remember to check both sides of the ballot.

# FREQUENTLY ASKED QUESTIONS

## **What is the last day to register to vote?**

State law allows voters to register up until 15 days before the election. The registration deadline for the November 8, 2022, General Election is **Monday, October 24, 2022**. You must register by this date to receive voting materials by mail for this election. However, conditional voter registration (CVR) is now available in California. Eligible voters who missed the 15-day registration deadline can go to the Elections Office from 14 days before Election Day (October 25) through the day of the election or to their polling place on Election Day (November 8), and conditionally register to vote.

## **When does my ballot get counted?**

No ballot can be “counted” until the polls close at 8 PM on Election Day. However, state law allows county election officials to begin opening and processing vote-by-mail ballots up to 29 calendar days before Election Day for the November 8, 2022, General Election.

If you vote the ballot that was mailed to you, your ballot will usually be processed within 24 hours of arriving at our office. That means if you mail your ballot back to us early enough, it will be processed before Election Day and become part of the results published at 8 PM that night.

If you vote at a polling place, your ballot will be tallied that day and included in the results after the polling place materials are delivered to our Elections Office in Auburn. These materials are delivered after the closing of the polling place on Election Day.

The last ballots to be counted are the vote-by-mail ballots mailed or dropped off at drop boxes a few days before Election Day or at polling places on Election Day, ballots mailed and postmarked by November 8, 2022 that are delivered by the post office up to seven (7) days after the election (November 15), and the provisional ballots or CVR ballots cast at polling places. These ballots are processed during the 30-day period following the election that is known as “Post-Election Canvass.”

## **What happens to provisional ballots and CVR ballots after the election? When are they counted?**

Every provisional and CVR ballot cast in Placer County is individually reviewed for eligibility after all materials from the polling places are returned and secured. The most frequent reasons for determining that a provisional or CVR ballot is not eligible to be counted are 1) the ballot envelope is not filled out correctly or 2) the voter cast a ballot through another mechanism (voted by mail or at another location or county within the state). Provisional and CVR ballots are usually counted within 48 hours after they are deemed eligible.

## **How do I work at a polling place?**

It's easy! If you would like to become a poll worker, you can contact our office at 530-886-5650 or visit our website at [www.placercountyelections.gov/serve-as-a-poll-worker-in-placer-county](http://www.placercountyelections.gov/serve-as-a-poll-worker-in-placer-county) and apply for a Poll Worker position.

## **I changed my signature since I first registered to vote. Will it matter?**

Yes, if your signature on your vote-by-mail ballot envelope does not compare with your voter registration signature, we cannot count your ballot. We will make our best effort to compare the signature on file to the one we find on the envelope you use to return the ballot. If for any reason we cannot determine it is a match, we will contact you by mail with a form you may use to confirm it was you that voted the ballot. If you are unsure of how you signed your most recent registration, we recommend that you call our office, and we will mail you a voter registration card. Alternatively, you can re-register online at [registertovote.ca.gov](http://registertovote.ca.gov). Re-registering will allow you to update our records so that we have a current signature on file for verification purposes.

# IMPORTANT DATES

## October 10, 2022 **BALLOTS MAILED TO VOTERS**

Ballots will be mailed no later than this date to all active registered voters in Placer County. If you lose or incorrectly mark your ballot, you may request a replacement ballot be mailed to you through November 1 or visit the Placer County Elections Office and cast a vote-by-mail ballot in person through Election Day.

## October 24, 2022 **LAST DAY TO REGISTER TO RECEIVE A BALLOT BY MAIL**

You must be registered by this date to receive voting materials by mail for this election. After this date, you must visit the Elections Office through Election Day or a polling place on Election Day to complete a Conditional Voter Registration and vote.

**Just Moved?** If you were already registered in the county and moved to a different address within the county (but did not re-register), you may vote at your new polling place on Election Day or the Elections Office from October 24 through Election Day, November 8, 2022.

## November 1, 2022 **LAST DAY FOR THE ELECTIONS OFFICE TO MAIL YOU A BALLOT**

This is the last day to request a replacement ballot to be mailed to you. For instructions on how to request a replacement ballot, please call the Elections Office at 530-886-5650 or e-mail us at [vote@placer.ca.gov](mailto:vote@placer.ca.gov).

## November 8, 2022 **ELECTION DAY! POLLING PLACES OPEN**

Polling places will be open from 7 AM to 8 PM. You may drop off your voted ballot to any polling place. However, if you prefer to vote at your designated polling place instead, bring your mailed ballot and envelope with you to avoid voting a provisional ballot. **Please note - your polling place may have changed. Check the back cover for your polling place location.**

## Important Things to Remember:

If you require a replacement ballot, you may stop by the Elections Office to obtain a replacement vote-by-mail ballot. You may also go to your assigned polling place in Placer County on Election Day and receive a poll ballot. Bring the original ballot and envelope that was mailed to you to avoid the potential of voting a provisional ballot.

- If you are coming in to pick up a replacement ballot for another person, you will need written authorization from that voter. If you are dropping off a completed ballot for another voter, make sure the authorization section of the envelope has been completed.
- For a mailed ballot to be considered on time and counted, it must be postmarked on or before November 8, 2022, and received by our Elections Office no later than November 15, 2022.
- Do not forget to **sign** the back of your vote-by-mail ballot envelope next to the red "X". The envelope flap will cover your signature so nobody will see it until it is matched by Elections Office personnel.

## How to Return Your Voted Ballot:

### By Mail:



You may vote your ballot anytime between receiving it and Election Day. Vote early and have your ballot released in the count on Election Night! If you vote your ballot early, mail it back to us in the prepaid postage envelope provided. Your ballot must be postmarked on or before Election Day and received by November 15 in order to be counted.

### In Person:



Hand deliver your ballot to the Auburn Elections Office or to any polling place or vote center in California.

### At a Drop Box Location:



We offer many official ballot drop boxes throughout Placer County in the 28 days prior to Election Day. Make sure your ballot is sealed inside its return envelope and that you have completed and signed your envelope before dropping it in the official drop box! Many locations have changed. See page "DROP" for a list of boxes/hours.

### At a Polling Place:



If you have an assigned polling place, it will be listed at the top left side of this page. You may visit this location on Election Day, Tuesday, November 8, where you can drop off your voted ballot, receive assistance, or bring in your ballot and envelope that was mailed to you and vote in person instead.
