**READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT.
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. Upon initial inspection we have determined that you did not sign your vote by mail or provisional ballot envelope. After further review we may have found your signature in an alternate location and approved your ballot. You may have already contacted our office to resolve this issue as well. In an abundance of caution, we mailed this letter to ensure you had ample time to resolve this issue.
2. Please check <http://www.placercountyelections.gov/vote-by-mail-tracking/> to determine your ballot status.
3. In order to ensure that your vote by mail or provisional ballot will be counted, an Unsigned Ballot Statement must be completed and returned as soon as possible, but no later than 5 p.m. two days prior to the certification of the election.
4. You must sign your name below where specified on the statement (Voter's Signature) and include your address.
5. Place your completed statement into the postage-paid return envelope if it is included with these instructions. If a return envelope is not included with these instructions, use your own mailing envelope addressed to your local elections official. Mail, deliver, or have the completed statement delivered to the elections official. Be sure there is sufficient postage if mailed and that the address of the elections official is correct.
6. If you do not wish to send the Unsigned Ballot Statement by mail or have it delivered, you may submit your completed Unsigned Ballot Statement by email or facsimile transmission to your local elections official using the information provided or submit your completed statement to a polling place within the county or a ballot drop-off box before the close of the polls on election day.
7. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

UNSIGNED BALLOT STATEMENT

I, _____, (please print) am a registered voter of Placer County, State of California. I declare under penalty of perjury that I requested (or I received) and returned a vote by mail or provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote by mail or provisional ballot envelope.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this statement means that my vote by mail or provisional ballot will be invalidated.
