## **Placer County gears up for Nov. 8 general election**

**Auburn, Calif.** -- The Placer County Elections Office is reminding residents about important dates and information leading up to the November 8, 2022, General Election.

Voter information guides and vote-by-mail ballots have already been distributed to all registered voters in Placer County. The guides provide information on candidates and ballot measures as well as important information on voter registration and voting options in the upcoming election.

**Important dates:**

- Oct. 10 County voter information guides and vote-by-mail ballots were mailed to voters by this date. Voters may begin returning ballots via mail, drop boxes or in person at the Elections Office (2956 Richardson Dr. in North Auburn).
- Oct. 24 Last day to register to vote and receive voter materials by mail
- Oct. 25 First day of conditional voter registration and the close of write-in candidate filing period for this election
- Oct. 27 Last day to file second pre-election campaign statements
- Oct. 29/30 Elections Office open weekend hours to assist voters, 10 a.m. - 3 p.m.
- Nov. 1 Last day to request a replacement vote-by-mail ballot via mail
- Nov. 5/6 Elections Office open weekend hours to assist voters, 10 a.m. - 3 p.m.
- Nov. 8 Election Day - Elections Office open to assist voters, 7 a.m. - 8 p.m.

Placer County residents who have not received their information guides and vote-by-mail ballots by Oct. 20 should contact the Elections Office at 530-886-5650 (toll-free in California at 1-800-824-8683) or [elections@placer.ca.gov](mailto:elections@placer.ca.gov). If you lose or damage your ballot, you must request a

replacement by Nov. 1 to receive it in the mail. Visit the Elections Office at 2956 Richardson Dr. in North Auburn for ballot replacements after Nov. 1 and through Election Day, Nov. 8.

The last day to register to vote for the November General Election is Oct. 24. Voter registration forms may be picked up at all post offices, libraries and California Department of Motor Vehicles, the Elections Office or completed online at <https://registertovote.ca.gov>.

For residents who miss the 15-day registration deadline, conditional voter registration is available. Eligible voters can come to the Elections Office 14 days before the election (Oct. 25) through Election Day (Nov. 8) to conditionally register to vote.

CVR voters are required to register and vote a ballot during the same visit. Voters may also visit a polling location on Election Day to conditionally register to vote and cast a ballot.

Registered voters who've interacted with the California Department of Motor Vehicles are urged to confirm their voter status, political party preference, address and all other pertinent information to confirm its accuracy.
