Candidate filing opens for the November 2, 2010 Gubernatorial General Election July 12, 2010 and closes August 6, 2010. If the incumbent fails to file by August 6, 2010 the filing period for that office will be extended to August 11, 2010 for individuals other than the incumbent. Placer County residents in the Tahoe area will also be able to file at the Tahoe City Library located at 740 North Lake Blvd, Tahoe City. Candidates can file for office there Tuesdays, Wednesdays, Thursdays, and Fridays from 12:00 PM through 4:00 PM. Because the library is closed on Mondays, candidate filing in Tahoe will begin on July 13, 2010 instead of July 12.
